CERTIFICATE OF INCORPORATION
OF

This is to Certify, That we, the undersigned, do hereby associate ourselves into a non-stock corporation under and by virtue of the laws of the State of North Carolina, as contained in Chapter ⁵⁵ 22 of the ~~Consolidated~~ **GENERAL** Statutes, entitled "Corporations," and the several amendments thereto, and to that end do hereby set forth:

1. The name of this corporation is
The North Carolina Society of Surveyors, INC.
2. The location of the principal office of the corporation in this State is at 117 - 1911 Building,
N.C. State College in the City of Raleigh,
County of Wake.
3. The objects for which this corporation is formed are as follows:
 - (a) The advancement of surveying knowledge and practice; the cultivation of friendly relations with all surveyors; the maintenance of high professional standards; the cooperation with other surveying societies, with a view to promoting the general surveying practice in North Carolina.

And in order properly to prosecute the objects and purposes above set forth, the corporation shall have full power and authority to purchase, lease and otherwise acquire, hold, mortgage, convey and otherwise dispose of all kinds of property, both real and personal, both in this State and in all other

States, Territories and dependencies of the United States, and generally to perform all acts which may be deemed necessary or expedient for the proper and successful prosecution of the objects and purposes for which the corporation is created.

4. The corporation is to have no capital stock.
